The above named student wishes to enroll and participate in martial arts training and activities conducted by Instructor Michael Laird. Occasionally other instructors may help or substitute for Mr. Laird. In consideration for permitting the student to enroll and participate in martial arts and physical training and activities, the student agrees to:

- 1) Obey all rules of conduct and instruction, respect other students, observers, and the rules of the school. These rules apply for demonstrations, promotions, and all other school based activities.
 - 2) Tuition is payable regardless of the number of classes attended by the student. Regular attendance is essential.
 - 3) In consideration for allowing the student to participate or enroll in martial art training and activities, the student voluntarily releases, discharges, relinquishes and waives any and all causes of action or claim for personal injury, property damage or wrongful death occurring to students as a result of participating or receiving instruction in said activities or any activities related thereto wherever or however the same may occur and for whatever period such activities or instructions may continue. Student makes such release and waiver on behalf of student, student's heirs, executors, administrators and assigns, and hereby releases, waives, discharges and relinquishes any cause of action or claim which may hereafter arise. Student agrees that under no circumstances will student, heirs, executors or assigns prosecute or present any claim for personal injury, property damage, or wrongful death against Michael Laird, or any approved substitute providing martial arts training or activities in connection with him, for any claim or cause of action whatsoever, whether the same shall arise by the negligence of any said person, or otherwise. It is the intention of the student by this agreement, to exempt and relieve Michael Laird and his agents or employees and other instructors from liability of any kind for personal injury, property damage or wrongful death caused by the negligence of any person.
 - 4) The student and guardian understand that martial arts training and activities can result in injuries, including serious injuries or even death. Activities may include (but are not limited to) choking, falling, kicking, striking, tumbling and other activities that could result in injury. Michael Laird and his instructors will exercise reasonable judgment, skill, and supervision to reduce the likelihood of any such injuries. Understanding this, the student understand and accepts the risks and agrees to the waiver and release of liability stated above, and agrees and understands that this is a complete waiver and release of responsibility of any claim against Michael Laird, and any and all persons associated with it, for any injury that may occur in the course of such martial arts training and activities, even if such injury is caused by negligence.
 - 5) I grant permission to Laird's Academy to use any pictures taken on site for use on our website or advertising material.
- I, the undersigned student (or guardian), have carefully read all of the foregoing and have had the opportunity to fully discuss any questions I may have with a representative for Michael Laird, including the nature and extent of any risks or dangers associated with such martial arts activities.
